### Membership Levels in the National Space Club & Foundation

The National Space Club & Foundation (NSCF) is the foremost entity devoted to fostering excellence in space activity through interaction between industry and government, and through a continuing program of educational support. Through its programs, activities, and awards, NSCF works to promote space leadership and youth education activities. The active involvement of senior members of government, industry and academia serves to stimulate a range of activities focused on these objectives. While your support and assistance helps NSCF to achieve its stated purpose and objectives, your membership returns many additional benefits, including opportunities to:

- Broaden your association in astronautics and related fields;
- Participate with others in support of our nation's space policies;
- Keep abreast of the latest activities in the field of astronautics and related sciences; and
- Receive discounted rates at program, receptions and functions in support of space activities and events.

Membership dues are renewable annually (July 1- June 30).

#### Individual Membership

U.S. citizens are able to join as individual members. Individuals (\$30/year) – may purchase a table or seats at the discounted member rate at the annual Goddard Memorial Dinner. Other benefits given to all individual members:

- Ability to seek election to the Club's Executive Committee;
- Allowed to vote in the Club's annual officer elections;
- Discounted member rate at all Club programs and events.

#### Association Membership

Aerospace Associations incorporated in the United States are offered one level of membership.

**Associations (\$2,500/year)** – 5 individual memberships in the National Space Club, with no additional dues payment required; each individual member is allowed to vote in the Club's annual officer elections.

#### Corporate Membership

Aerospace companies incorporated in the United States can choose among four levels of membership:

- **Silver (\$4,000/year)** – 15 individual memberships in the National Space Club, with no additional dues payment required; each individual member is allowed to vote in the Club's annual officer elections.
- **Gold (\$7,000/year)** – 20 individual memberships in the National Space Club with no additional dues payment required; each individual member is allowed to vote in the Club's annual officer elections.
- **Platinum (\$10,000/year)** – 30 individual memberships in the National Space Club with no additional dues payment required; each individual member is allowed to vote in the Club's annual officer elections.
- **Diamond (\$15,000/year)** – 40 individual memberships in the National Space Club with no additional dues payment required; each individual member is allowed to vote in the Club's annual officer elections.

#### Other benefits given to all corporate members:

- Appointment of one nominee to the Honorary Board. This person will participate in the nomination and voting process for the Goddard Trophy Award winner;
- Discounted member rate at all Club programs and events;
- Ability to host Club-invited government guests at any tables purchased for the annual Goddard Memorial Dinner and other Club programs.
